

Joanne McEnroy - During the month of July my husband and I chaperoned a group of foreign exchange students on a bus trip across the United States. Call us crazy! I'm supposed to be retired from teaching! But, we volunteered to be part of the "Discover America 2015" rotary Exchange Student Tour - (105) kids, 7 adults, you do the math) - who would visit 22 states in 31 days! It was not always easy but it was an adventure! As a group we represented twenty-seven countries from around the world. The students had spent the year prior attending high schools, largely in the upstate NY and southern Canadian regions and this would be their 'dernier hourra' before returning home. Despite the fact that we visited some of the most beautiful and man made natural wonders that our country has to offer. The best part of the trip was the students themselves! It takes a certain kind of gumption to leave, at the age of 15, 16, or 17, everything and everyone that you know, for destinations unknown! To come to a place where you do not speak the language, ("I thought I could," most of them said, when asked about their English skills upon arrival) and live with a family that you know nothing about until you land on their doorstep!

But these kids did just that! And that "gumption" is what delighted us on every one of our days together! Their enthusiasm was contagious and their thirst to learn everything "American" made us pause to reflect on so many of the things we have taken for granted. (Like 30-pack donuts from Walmart and high school elective classes, for example) What I liked best about them though was the tolerance, maturity and kindness that I witnessed from each and every one of them throughout our journey. No cliques, no bullies, no drama, no angst, None of the craziness that we-who-have-lived it, has come to expect from a group this large (and that co-ed!). These kids were different because they were different! What set them apart is what set them apart!

"Why can't people be like this all the time?" a student from Taiwan asked after one particularly joyous day that ended with a jump-up cultural exchange dance party around a motel pool. "Well, that is why you are here, Ryokah. So that some day, they might be." He understood. No language barrier there! And so that is how we spent our summer vacation! We learned more than we taught We received more than we gave. And for sure, we were two very tired old souls by the time we got off the bus!!!


Larry Hohler - Yvette and I made our annual visit to Kenya in September to help celebrate the 10th anniversary of the opening of the Jerusha Mwiraria Hope Children's Home in Meru. The celebratory feast included goat, rice, chapattis, and cake for dessert, accompanied by many speeches and much singing and dancing. The orphans who were taken off the streets 10 years ago are now in their late teens and early 20's. Two are in technical training schools, four are enrolled in Kenyan universities, one is living independently, and most of the rest are in secondary schools. During our visit we took 20 year old Catherine Nkatha to Chuka to enroll at Rubati Teacher Training College. While driving her there, she told us she didn't plan to be a teacher for very long, and expected to be a head mistress with a school of her own before she was 30. We are very proud of our collegians but we are finding it daunting to cover the increased expense involved in providing for their educations .Several of our donors (cont. on p.6. (see Members)

have stepped up to help. Rocco Damato, a former Smithtown teacher who is CEO of the Bazzini Foods Corporation, has provided a grant for the purpose of buying and marketing maize, and part of the profits are being used to defray some of the educational costs.

Another highlight of our visit was the unpacking and shelving of thousands of books that were collected by the Global Club at Shoreham Wading River High School and sent to Kenya over a year ago. (Some of the books were donated by students at Smithtown High School East, Accompsett Elementary and St. James Elementary schools) Shelving had to be built in two rooms of our Technical Training Centre in order to accommodate them. We spent several days working with our kids to sort and organize this avalanche of reading material. Teachers from several local elementary schools came later to pick up books that will stock their buildings..

We find it amazing that 10 years have passed since we got in the business of providing for orphans. It is very satisfying to observe the transition from very needy street children to young adults who are on the way to developing their full potential. (See the photo on p. 9)

Bobbi Mastrangelo - In October, Bobbi received the National DAR "Women in the Arts Recognition Award" at the Lake Wales Florida Chapter of the Daughters of the American Revolution. The award recipient is expected to have contributed to her artistic field in an outstanding manner beyond mastery of technique. Ellen Gordon, who nominated Bobbi, was especially interested in the art work calling for environmental action: "When the People Care."





Have You Paid Your Dues For 2016?


